- You can find information on:
- 1) Money spent on lobbying (not by NGOs)
- 2) Numbers of lobbyists (lobbying employees
 - + Euro Parl passes)
- 3) Topics lobbied on
- 4) Meetings with commissioners, cabinets, directors-general (not all Commission lobby meetings)
- 5) Declared meetings with MEPs
- Anyone lobbying or trying to influence EU decision-making should register



But EU lobby register data is not perfect....

The register remains

voluntary: it is not legallybinding, and the sanctions
are weak.


This means that there are **3** problems with the data.





SCHRÖDINGER'S LOBBYING

1. There is some lobbying going on in Brussels (or elsewhere on EU topics) which is **not captured by the register**






2. It also means there is some **unreliable** or **implausible data**.

Almost all data is selfdeclared (key exceptions include EU Parliament access passes and Commission lobby meetings) and some lobbyists declare too much while others declare too little

In September 2022 we complained about **430 entries**. Response:

"Only 3% were correct from the outset and, whilst in **59%** of total cases the registrant provided a satisfactory update, **38%** were removed from the register."







Researching with LobbyFacts:

What do you mean, dodgy data?



Today LobbyFacts.eu shows that **71%** of registrants declaring the highest annual lobby spending in the EU lobby register are implausible.

From Huawei to Shell: corporate lobbies unimpededly recruit former EU Parliament staff



The European Parliament presents hardly any obstacles to former MEP assistants who wish to become lobbyists. There are no consequences for former staff who disregard the duty to report new work for approval, leaving the Parliament unaware of conflicts of interest. Even if they move on to lobby on legislation that they were involved with as political staff, they often easily receive a lobby pass.
